
### Jessica Keffer - Arts Nominated by Breathitt County

### Graham-Cassidy ACA Repeal: Senate Vote - A No Go!

On September 26, Majority Leader Sen. Mitch McConnell (R-KY) pulled the Graham-Cassidy bill, the most recent attempt by Senate Republicans to repeal and replace the Affordable Care Act (ACA). Senators Bill Cassidy (R-LA) and Lindsey Graham (R-SC) were leading the charge on the repeal bill. The vote on this bill was originally scheduled for Wednesday, September 27.

Three Republican Senators declared that they would vote no on the bill: Sen. Rand Paul (R-KY), Sen. John McCain (R-AZ) and Sen. Susan Collins (R-ME).

Supporters of the bill hoped that it would pass as part of the budget reconciliation process for fiscal year 2017, which would have allowed the bill to pass with a simple majority (51 votes or more – Vice President Pence is able to cast a tie of a 50/50 outcome). The budget reconciliation process expires on September 30.

This bill would have been devastating for children and youth with disabilities as it would:

- Cap and block grant Medicaid (the equivalent of Medicaid cuts)
- Cut funding for Medicaid expansion
- Allow insurers to charge individuals with pre-existing conditions more money for health coverage

The Congressional Budget Office (CBO) rushed to score this bill and reported that "millions fewer people would have comprehensive health insurance over the next ten years under Graham-Cassidy."

Thank you for contacting your Senators and encouraging them to vote no on Graham-Cassidy and for speaking up for children and youth with disabilities who rely on Medicaid coverage. Your actions made a difference

### House and Senate Pass Bipartisan EHDI Bill

The Early Hearing Detection and Intervention (EHDI) Act of 2017 has passed in both the U.S. Senate and the U.S. House of Representatives. The legislation reauthorizes newborn hearing screening programs for five years, through fiscal year 2022.

The House bill, <u>H.R. 1539</u>, was introduced on March 15, 2017 and sponsored by Rep. Brett Guthrie (R-KY). The bill has 25 cosponsors. The Senate bill, <u>S. 652</u>, was also introduced on March 15, 2017 and sponsored by Sen. Rob Portman (R-OH). This bill has 13 cosponsors.

In a <u>statement from Sen. Rob Portman's office</u>: "This bill will reauthorize current research and improve public health programs for early detection, diagnosis, and treatment of hearing loss in newborns, infants, and young children."
