Mini Grants!

1. Kentucky CEC has budgeted \$650 for each mini-grant award. There will be a total of **eight** mini-grants available.
2. The following priority areas have been designated: 1) teacher training; 2) membership; and 3) development and implementation of model programs.
3. The proposal must address an identified need, a rationale, a description of the proposed project and a budget.
4. A copy of the mini-grant proposal can be found [on the KYCEC website](#). Information will be sent out to members periodically through emails and newsletters. The deadline for mini-grant proposals is January 31. Written notice of approval or disapproval will be sent by the Mini-Grant Chair to the contact person upon review of the proposals.
5. Grants proposals will be competitive. Therefore, close adherence to the format, written communication skills and the specifics of the proposal's content will all be factors considered by the review committee.
6. Award recipients agree to submit a summary and an evaluation of the mini-grant activity.
7. All proposals should be submitted electronically through the KYCEC website.
