The Trump Administration released its proposal for Fiscal Year (FY) 2021 spending. Overall, the budget proposal cuts the Department of Education (ED) by \$6.4 billion, or 8.4 percent. The budget also includes \$5 billion for proposed Education Freedom Scholarships, or tax credits for vouchers that could be used toward private school tuition.

The proposed Education Freedom Scholarships must be rejected. Public funds for private school vouchers are contrary to the best interests of students, families, the public-school system, local communities and taxpayers. Further, private school vouchers undermine civil rights laws such as IDEA by stripping students with disabilities of their civil rights.




Introducing
