#### **ADVOCACY UPDATES**

The Special Education Legislative **Summit** (SELS) is a joint activity organized by the Council for Exceptional Children and the Council of Administrators of Special Education. Typically held in Washington, D.C. during July, SELS is an opportunity for educators from across the country to advocate for change with Members of Congress. Your 2023 KY team was 13 members strong, and included pre-service teachers, higher education faculty, classroom teachers, a doctoral student, and special education consultants. Team KY participated in in-depth training about three primary issues and received legislative updates on key issues impacting the field of special education. The main initiatives of focus were: appropriations, mental health, and educator shortages. We met with Senator McConnell and Senator Paul's staff, as well as five of our U.S. Representatives to not only share the needs across the Commonwealth, but also to relay our appreciation for their ongoing support. On July 10, 2023, the IDEA Full Funding Act was introduced in the House, and Team KY also advocated for our members of Congress to co-sponsor the bill. Our diverse voices from across the field proudly represented KYCEC members and KY educators during SELS 2023.

## ACADEMICS: Matthew Beerwart, Lone Oak Middle, McCracken County

Matthew is a phenomenal young man who also has Autism. He has worked through emotional regulation difficulties to join the school plays as well as choir. Matthew dedicates himself to memorizing lines, practicing for choir and using his coping strategies when faced with challenges. He radiates joy when he performs and is an inspiration to many classmates.

ARTS: Lacyann Howard, Newport High School, Newport Independent Lacyann is an excellent artist who has had artwork featured all across the Commonwealth of KY. Lacyann also has Retinitis Pigmentosa, which is a rare, progressive eye disease that affects her peripheral vision, and she is legally blind. She draws inspiration from her challenges, but others have made it tough for her by belittling her vision loss and poverty. She does not want others to feel that same humiliation, so Lacyann makes it her mission to inspire and spread kindness.





## SCHOOL & COMMUNITY ACTIVITIES: Noah Lyvers, LaRue County High School

Noah was diagnosed as a young child with Oculomotor apraxia, which makes purposeful eye movement difficult and includes developmental delays. Noah has played flag football, basketball, and softball for the Special Olympics for the past four years. With the Special Olympics, he has found a community of friends that he encourages during practices and games.

SELF-ADVOCACY: Zurie Basso, North Middle School, Hardin County
For many students with autism, the executive function required to
effectively self-advocate often makes this a difficult task. Zurie was
overwhelmed by middle school and stimming behaviors became more
apparent, hindering her ability to self-advocate. Through communication,
collaboration, social stories and role play, Zurie has learned to to build
appropriate friendships, care for personal hygiene and self-advocate. In
her own words, "I can do anything....I feel like a rockstar!"





## TRANSITION: Rebecca Robertson, Ahrens Educational Resource Center, Jefferson County

Rebecca's unwavering spirit and commitment to self-improvement have not only inspired those around her, but have also ignited a positive change within the school community. Through her participation in the Ahrens Work Transition Program, she has grown both professionally and personally, and her achievements at Omni Hotels and independent transportation exemplify her remarkable progress.

I love the <u>HLP Leadership Guides</u>. The guides are a tremendous resource for administrators and building level instructional coaches who may not have a special education background. Students spoke to Kentucky legislators about these issues, as well as their experiences as EKU pre-service special education teachers.

#### **Early Education for a Future World**

Yates Elementary School, Fayette Co Public Schools

The goal of this project was to purchase inclusive materials to support the learning & development of all children in a public preschool classroom. Over 95% of children in the classroom are from minoritized racial groups & approximately 55% of all children fall into at least one disability category. Research has shown that high quality intervention & instruction in the early years of children's development leads to increased positive outcomes later in a child's life including cognitive development, academic achievement, & labor market success (Early Childhood Technical Assistance Center, 2023). Racially & culturally representative class materials along with high quality sensory and adaptive materials will assist in preparing children for a highly globalized and more inclusive world.
